INSTRUCTIONS FOR NEW BIDDER REGISTRATION FOR KARLA'S/UKRAINETZ AUCTIONS

1. From ukrainetzauction.com click the Online Auctions tab, or go directly to ukrainetzauction.hibid.com
2. Go to the either the three lines in the top left or right corner, or click on Login/New Bidder.
3. Enter your email address twice to verify it.
4. Then go to STEP 2 and fill in the Account information. a. Choose an user name and password b. Select the options you wish to use on your account (most choose to hide Username from public) c. Then create your account
5. Then select PAYMENT METHOD. a. Enter your credit card and all information requested. (This must match your Credit Card statement) b. Save Payment Method (it will save if it works, if not double-check the information that you entered. If you are still having issues, contact your bank, as the Auction company cannot assist you with this part)
6. Select the auction you are wanting to bid in.
7. Click the Auction Hammer on the Black line and enter your username & password that you created in 4a.
8. If you do not wish to use your Credit card for payment, make note of e-transfer under remarks. CASH PAYMENT IS NOT AN OPTION, AS WE DO NOT HAVE CASH ON SITE.
